Dear Parents, Guardians and Carers,

Re: Changes to Data Protection Law

You may be aware that from 25th May 2018, the rules around data protection are changing. The 'General Data Protection Regulation' (GDPR) will change how we can use personal data and keep it safe, and will also strengthen your rights over your own data.

The point of this is to make sure sensitive or private information about yourselves and your child stays safe. Whilst it is similar to the current Data Protection Act in many ways, there are a few differences, so we need to make a few changes to our procedures in order to ensure we remain compliant.

One of these changes is that we have updated our privacy notice. There are two versions of the privacy notice, one for parents, guardians and carers and one for pupils. Both are available from the 'Policies' section of the school website.

As part of our work to comply with the GDPR, we are also seeking consent for using photographs or videos of your child on our website, social media accounts, internal displays and other school materials. We have enclosed this form, and would appreciate it if you filled this out and returned it to your child's Form Tutor by Friday 8th June 2018.
